Please note that the Organisers will try to accommodate first preference for helper duties but this may not be possible. First entries received get priority. Riders may be disqualified if their helper does not do their duty.

Entry Conditions

1. Rider may ride a maximum of 4 jumping classes on 1 horse.
2. Horse/rider combination can only enter 3 consecutive heights in the competition ring, with Hors Concours available at the highest height.
3. Rider may ride a maximum of 3 dressage tests on 1 horse, over two consecutive levels.
4. Rider may ride more than 1 horse and one horse cannot be ridden by more than one rider.
5. A helper needs to be supplied per horse competing or training, limited self-help available if arranged with organiser.
6. Prices are: - \$15 per horse per competitive jumping class
- \$10 per class for jumping training rounds or 4 for \$35
- \$15 per dressage test or 3 for \$40
- with \$10 ground fee per horse
7. Competitive classes to be split into PCAWA and Open.
8. PCAWA gear check and PCAWA/EA show jump rules apply.
9. Riders to be in formal pony club uniform or hacking attire, long sleeves, to be worn for competitive classes. Plaiting not required
10. Neat attire with long sleeves required for training rounds and tests. Plaiting not required.
11. All riders must be gear checked before they warm up or compete.
12. Entries to be sent (emailed or posted) to email /address below – oghpcevents@gmail.com
13. Pre entries close Tuesday 9th February 2016 or when classes full.
14. Payment may be made by Cheque/Money Order to: Orange Grove Horse & Pony Club or Direct Deposit. **PLEASE NOTE NEW BANK ACCOUNT DETAILS**

15. Helper list, Jump and Dressage Draw will be available on Orange Grove Horse and Pony Club's website (<http://www.oghpc.org/>) and on Cavaletti by Friday 12th February 2016.
16. No one under 18 years may be left on the grounds without a parent or guardian.
17. All competitors to clean up after themselves and their horses.
18. Competitors must notify the organizer by phone or email provided about withdrawal of entry by close of entries to obtain a refund minus \$10 book keeping fee.
After this date, a refund (minus book keeping fee) will only be given if a Vet's or Doctors certificate is received by the organizer.
19. Orange Grove Horse & Pony Club (OGHPC) retains the right to change the program at any time, combine, cancel or reschedule any event.
20. **All competitors must have current PCAWA, Open PCAWA or EWA insurance.**
21. No riding or lunging in any of the sand arenas, lunging may be done away from the main area.
22. **NO DOGS ALLOWED ON THE GROUNDS.**
