Entry Conditions:

1. It is a condition of entry that all riders will provide a Helper. Helpers must report to the Clubroom to sign in for their duty. It is the rider's responsibility to check the list of helper duties.

Entry forms must be correctly completed and full payment must be received by the closing date (Monday 25th May 2014 at 10pm). Payment can be made by direct transfer to the Orange Grove Horse & Pony Club bank account or by Cheque/Money Order. – BSB: 633000 Account #: 151543915. 3. Pony Club Australia Dressage and Gear Checking Rules apply. Gear check is per PCAWA guidelines.
4. The organising committee reserves the right to alter or cancel any competition at its discretion. The committee reserves the right to refuse any entry at its discretion.
5. Scratchings will be accepted until the closing date with full refund of entries. Refund of entry fees after that time will not be made except with the presentation of a vet certificate or a doctor's certificate within 5 days of the event. 10% of entry fee will be retained to cover administration. Scratchings to oghpcevents@gmail.com. (up to the night before competition)
6. It is recommended that competitors report to the Marshall/Gear Checker for inspection at least 20 minutes prior to competing. Riders who do not complete a gear check will incur elimination.
7. Catering: Will be provided by the OGHPC Canteen.
8. Lungeing: There is NO lungeing in the warm up arena. If you wish to lunge your horse you must do so away from the main arena so as not to interfere with other competitors. Helmets must be worn whilst lungeing. Correct protocol in the warm up arena is expected.
9. Officials and Volunteers: These people are essential in the running of our competitions and events. Please treat them with respect. Poor sportsmanship, verbal or physical bullying behaviour will not be tolerated. This may be reported to the relevant authority and disciplinary action will be taken where appropriate.
10. No dogs allowed on the grounds at any time.
11. Please spread manure outside of yards and clean up any rubbish and hay.
